V-2022-09: ABE Consulting, Inc., c/o Abe Abouhamdan, applicant, DHCB Holdings, LLC, Chris Biddle and David Hall, property owner, seeks a variance from the Arcade Land Use Management Code, Article 27, "Exurban and Rural Design and Improvement Requirements," Chapter 27.4, "Design Requirements for Blocks and Lots," Section 27.4.2, "Design Requirements for Lots," to increase the number of abutting flag lots permitted from two to four, for 6.99 acres fronting on east side of State Route 82 South (Map/Parcels 070/049F1 and 070/049F) (937 Highway 82 South). Existing zoning: RR-2 (Rural Residential District). Proposed use: subdivision of four lots for detached single-family dwellings.
